Q4/2024 actuals

- Pihlajalinna introduced a mobile AI-based magnet unit in December. The magnetic unit conducts research in Southeastern Finland and Mikkeli.
- Pihlajalinna Sydänkaista remote care pathway is one of the final three nominees in Lääkäriliitto's quality award competition, and the winner will be announced in January. It is estimated that Pihlajalinna Sydänkaista reduces the probability of a re-infarction by up to 40 percent. It suits, for example, for the range of public healthcare and occupational healthcare services.
- The district court sentenced the city of Jämsä to pay Jämsän Terveys EUR 1.3 million of additional costs caused by the COVID-19 pandemic, plus default interest and court costs.
- Pihlajalinna and insurance company If starts a cooperation that will enable If's customers to have even more comprehensive services in Pihlajalinna in the future. The companies will also develop service concepts offered to joint customers during 2025.
- The regulation on hospital operations takes effect on 1 January 2025, and it will continue to allow the use of a private service provider for day surgery and short-stay surgery, such as joint replacement surgeries. For example, in 2024, almost 900 joint replacements have been performed at Jokilaakso Hospital, and according to statistics by the Finnish Institute of Health and Welfare, it is one of Finland's highest-quality joint replacement hospitals (joint replacement operations that require early reoperations).



Q4/2024 frequently discussed topics

- Pihlajalinna has continued determined measures to strengthen the company's profitability. This is particularly evident in commercial measures, enhanced procurement processes and in an increase of billable customer work
- Changes to the total outsourcing agreements and adjustments to meet the needs of wellbeing service counties areas have continued
- The growth of supply of private healthcare services remained stable
- At the end of the year, the demand increased especially due to the high number of upper respiratory tract infections and slippery weather
